About Inner Healing Prayer (IHP)

IHP is not counseling. It is a gentle and powerful prayer tool for inner healing and deliverance. At Heart Journey Christian Counseling, LLC, you can receive IHP separately or as an adjunct to counseling. Counseling will help you to walk out and steward the freedom you received in prayer but is not required.

The goal of IHP is to uncover any root and spiritual issues that hinder your personal growth and relationship with God and others.

How it Works:

The role of the prayer minister is to help guide you through the process of connecting with the Godhead.

Your role is to listen and share what you have experienced after you have inquired of the Lord.

As the Holy Spirit leads, you are invited to ask Father God, Jesus Christ, and the Holy Spirit questions about:

- 1) Wounds that need to be healed
- 2) People to forgive
- 3) Unhealthy relational and generational patterns
- 4) Sins to repent and renounce
- 5) Lies you are believing

Expect your appointment to last approximately two hours.

How to Prepare for your appointment:

- 1) Begin praying and asking the Lord to reveal what memories and emotions He would like to heal.
- 2) Come humble, ready to forgive, and open to look at old hurts.
- 3) Expect to hear from God and for Him to heal you.
- 4) Some people find it beneficial to fast leading up to ministry time.

After your appointment you would want to have some time of rest and reflection.
